Per Smt. Shanta Shastry, Member (A)

The present case is squarely covered by the judgement of Calcutta Bench of the Tribunal in OA-1241/1996 wherein the Tribunal has held that the applicants of the District Rehabilitation Centre, Midnapore are employees of the Central Government through their salary is being paid as per the scales of the State Government. The OA was allowed with a direction to the respondents to treat the employees as employees of the Central Government and to grant reliefs to the employees in accordance with the rules in respect of salary, provident fund, etc with immediate effect.

- The learned counsel for the applicant states that this order of the Calcutta Bench has been taken in appeal to the High Court of Calcutta. However, since no stay is granted or any decision as yet given, the judgement of Calcutta Bench is binding on us.
- 3. We therefore pass the same orders as in the aforesaid OA. The OA is disposed of accordingly. No costs.
