

As the relief in O.A. is in respect of determination of legality of that examination, he has pointed out that for the said reason this O.A. is infructuous. In view of said statement, no cause of action survives and O.A. is infructuous.

3. For the aforesaid reason, the O.A. is dismissed. There will be no order as to costs.
