ORDER

In this application made under Section 19 of the Administrative Tribunals Act of 1985, the applicant has sought for a direction to respondents 1-3 to transfer R-4 from Mysore Division to Bangalore Division or alternatively treat him as his junior in the relevant cadre.

Shri A.N.Venugopal, learned counsel for R 1-3 produced before us Office Order No. T-CELL/C-12/86 dt 8th May, 86 according sanction to the retirement of R-4 from 31-5-86. Shri Venugopal also submits that R-4 has retired on 31-5-86 and is no longer holding the post. In these circumstances, the grievance of the applicant no longer survives for consideration. We therefore dismiss this application as having become unnecessary. But in the circumstances of the case, we direct the parties to bear the costs.
