Shri Padmarajaiah invites our attention to the memo dated  
15-11-82 filed by the then Senior Central Govt Standing  
Counsel in W.P. No 19482/79 when the matter was pending  
in the High Court. The said memo reads as under:

'The Petitioner has been ~~promoted~~ promoted after the above W.P., to chargeman Gr II on regular basis and his seniority has been restored in Chargeman Grade II wef 20-2-1976. Further, he was promoted as Chargeman Gde I wef 15-9-1981, and as Asst. Foreman wef 15-3-82.
