ORDERIn the above application this Tribunal has passed the
following Order:-

"Both counsel state that no notification has been issued
U/s 14(2) of the Administrative Tribunals Act, 1985, so
as to attract the jurisdiction of the Central Administrative
Tribunal over the National Institute of Mental Health and
Neuro Sciences (NIMHANS) - respondent No.3 - which is an

autonomous body registered under the Societies Registration Act, 1960. Since the prayer in the W.P. is to direct the 3rd respondent to announce or notify the panel of names selected for the post of Asst. Professor of Psychiatric Social work as notified on 24-9-79 and interviewed on 22-2-80, a notification under the Act is a sine quo non for entertaining the writ petition transferred from the High Court of Karnataka to this Bench of the Tribunal. We therefore direct the Registrar to take steps to retransfer this writ petition to the High Court addressing its Registrar suitably in the matter.
