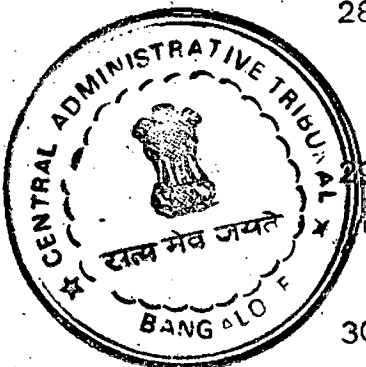

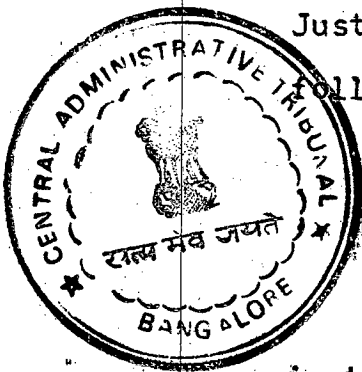

following :

O R D E R

As the questions that arise for determination  
in these applications made under Section 19 of the



Administrative Tribunals Act, 1985 ('the Act') are common, we propose to dispose of them by a common order.

2. All the 63 applicants before us are working either as Group-C or Group-D employees in one or the other dispensary or office unit of the Central Government Health Scheme ('CGHS') - a Department of the Government of India - situated in Bangalore City.

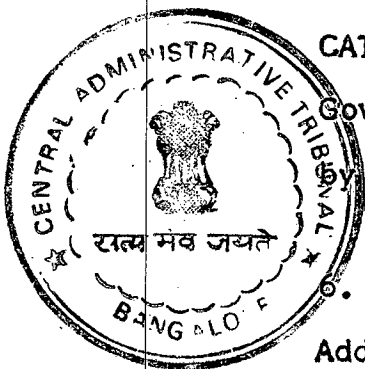
3. For the months of May and June, 1988 there were no deductions in the salaries paid or payable to the applicants. But, in their respective salaries paid for the month of July, 1988, there were deductions for period varying from 1 to 6 days relating to the month of May, 1988. On those deductions one Shri C.M. Hoogar, applicant in Application No.1538 of 1988, who happens to be the General Secretary of the All India Central Government Health Scheme Employees Association, Bangalore ('Association') represented to the Deputy Director, Central Government Health Scheme, Bangalore ('Director') - respondent urging for refund of the amounts deducted from the respective salaries of the applicants and others paid in July 1988. Very rightly treating the same, as individual representations made by the applicant and others, the Director has made an identical order on 18.8.1988 against each of the applicants and others. In these separate but identical applications the applicants have challenged the orders made against them on



more than one ground and have sought for a direction to the respondent to refund the respective amounts recovered from them.

4. In a common reply, the respondent has justified the orders made against the applicants and the recoveries made from each of them.

5. Shri H. Basavaraju, learned counsel for the applicants, contends, that the deductions made and the consequent orders made on 18.8.1988 by the Director treating the periods referred to in the respective orders as dies non, without affording them an opportunity of hearing, was violative of one of the basic components of the principles of natural justice viz., audi alteram partem and was illegal and therefore, we should direct refund to the respective applicants forthwith. In support of his contention Shri Basavaraju strongly relies on the ruling of the Supreme Court in STATE OF ORISSA v. Dr. (Miss.) BINA PANI DEI AND OTHERS (AIR 1967 SC 1269), a Division Bench ruling of the Chandigarh Bench of this Tribunal in RAMJI DASS V. UNION OF INDIA AND OTHERS (ATR 1986 (2) CAT 455) and circular instructions issued by Government reiterating the very principles enunciated by the Courts on the point.



6. Shri M. Vasudeva Rao, learned Additional Central Government Standing Counsel appearing for the respondent, refuting the contention of Shri Basavaraju sought to support the

recoveries and the orders made by the Director.

7. In the salaries payable and paid to the applicants for the months of May and June, 1988, there were no deductions and therefore, they had no grievance with the same. But, in the salaries paid to them for the month of July, 1988 there were deductions relating to the month of May, 1988 for which reasons are stated by the Director in her orders made on 18-8-1988 against the applicants. One such order made against the applicant in Application No. 1538 of 1988, adopted in all other cases, with details concerning each of them, reads thus:

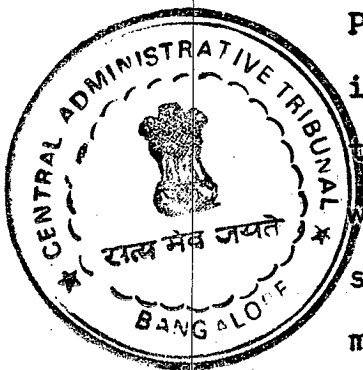
A reference is invited to Circular instructions issued by this office vide our letter No.B-12011/4/85/BNG/CGHS/2554 dated 19th April, 1988 which was circulated amongst the staff members indicating that absence even for part of a day would be liable to forfeit their pay for the days of absence from duty besides rendering themselves liable for disciplinary action. In spite of the Circular instructions it is seen that the officials have participated in the pen down strike on 16th, 17th, 19th, 23rd, 24th and 25th May, 1988 and thereby absented themselves from duty willfully for part of a day on several days. According to Government of India Instruction 3 below Rule 11 of C.C.S. C.C.A Rules and Rule 17(1) of FRs periods of absence on 16th, 17th, 19th, 23rd, 24th, 25th May, 1988 have been treated as unauthorised and the salary for that day has been cut. The period of unauthorised absence treated as dies non would not count as service for purpose of Pension and Leave etc. and does not constitute break in service.

The fact that before effecting recoveries for the periods referred to in the impugned orders or before making the impugned orders on 18-8-1988, the Director had not issued show cause notices to the applicants and had not also afforded them an opportunity of oral hearing is not rightly disputed by the respondent and is apparent from the proceedings themselves.

8. It is obvious that whenever deductions are effected from the salary payable to a civil servant for whatever reason that be, such deductions will undoubtedly result in civil consequences to him. If so, the same cannot be done without conforming to the principles of natural justice, of atleast issuing a show cause notice affording an opportunity to the concerned civil servant to state his case, before deciding the matter, which is well settled in law and is concluded by the ruling of the Supreme Court in Bina Pani Dei's case reiterated by the Chandigarh Bench in Ramji Dass case on similar facts. What is stated by the Government of India in its O.M.No.33011/2(S)84-Estt (B) dated 2-5-1985 extracted at page 66 of Swamy's compilation of Fundamental Rules and Supplementary Rules, corrected upto 1-7-87, Part I - General Rules (Except T.A. Rules) is also in conformity with the same. On the application of these principles to the fact-situations in the case, we cannot uphold the recoveries effected from the salaries of the applicants and the consequent orders made against them on 18-8-1988. On this very conclusion, we cannot uphold the contention of



Sri Vasudeva Rao that a remand will only be an exercise in futility, which also does not accord with facts. On this conclusion, we cannot ourselves examine the merits which in any event has to be done in the first instance, by the Director by conforming to the principles of natural justice. But, before that is done, we do not consider it proper to direct the refunds as strongly urged by Sri Basavaraju.

9. Sri Basavaraju does not dispute that recoveries had already been made from the salaries of the applicants for the month of July, 1988. If that is so, we consider it proper not to direct the respondent or other authorities to refund the amounts recovered from the applicants till a fresh decision is taken on the same. We need hardly say that after a decision is taken and if that decision is in favour of all or any of the applicants, then the authorities are bound to refund the amounts to the concerned applicant with expedition. We have not doubt that they will do so. But, if that decision were to be against the applicants and if they are aggrieved then, they are at liberty to approach this Tribunal with fresh applications on all such grounds as are available to them.

10. Sri Vasudeva Rao seeks one month's time to issue fresh show cause notices to the applicants. Sri Basavaraju also seeks time likewise for filing written objections or reply to the same from the date of receipt of such notices by the applicants.





We consider it proper to grant both these requests.

11. In the light of our above discussion, we make the following orders and directions:-

- 1) We quash the orders impugned in all these applications.
- 2) We reserve liberty to the respondent or such other officer who is competent to decide the matter, to issue fresh show cause notices to the applicants on or before 31-12-1988, setting out all such circumstances as are necessary for them to state on the recoveries already made from the salaries paid to him for the month of July, 1988. We grant one month's time to the applicants to file their written representations to such notices from the date of their receipt, with liberty to urge all such grounds as are available to them. The respondent is thereafter directed to complete the proceedings with expedition and in any event within 2 months thereafter.
- 3) We direct the respondent to modulate the refunds, if any, that become due to the applicants, in accordance with the aforesaid orders to be made thereafter.



12. Applications are disposed of in the above terms. But, in the circumstances of the cases, we direct the parties to bear their own costs.
