K.S. Puttaswamy, Vice-Chairman, made the following :

O R D E R

This is a transferred application and received  
from the High Court of Karnataka under Section 29  
of the Administrative Tribunals Act, 1985 (Act).



2. The applicant a released Emergency Commissioned Officer (ECO) was appointed on 5-6-1972 to the Karnataka Administrative Service (KAS) Junior Scale, Class I, as Probationer. In due course, he <sup>he</sup> ~~was been~~ <sup>he</sup> selected and appointed to the Indian Administrative Service ('I.A.S.') in accordance with the Indian Administrative Service (Appointment by Promotion) Regulations, 1965 ('Regulations').

3. In this application the applicant <sup>he has</sup> claimed that he should have been appointed to I.A.S. from 1.1.1977 and in any event from 1.1.1981, which is resisted by the respondents on diverse grounds.

4. When this case was pending before the High Court of Karnataka and this Tribunal in pursuance of an order of the Supreme Court and this Tribunal, Government of Karnataka by its Notification No. DPS JS/KG dated 5.7.85 had published a provisional gradation list of the Karnataka Administrative Officers <sup>as</sup> on 1.1.1987 and the same <sup>he</sup> ~~had~~ <sup>is</sup> not far been finalised. In the light of these developments Sri A.M. Farooq, learned counsel for the applicant, files a memo praying for permission to withdraw this application with liberty reserved to file a fresh application on the finalisation of the seniority list and changes, if any to be made on his provisional confirmation to KAS. We <sup>to</sup> consider it proper/grant this request. We, therefore, dismiss this application as withdrawn



by the applicant with liberty reserved to file a fresh application on the finalisation of the seniority list in the cadre and the consequent revision, if any, in the date of confirmation of the applicant with no order as to costs.
