O R D E R

The facts of these cases and the question of law that  
arises for determination in these cases are similar to those  
in A Nos. 470 to 472 and connected cases RAMU AND OTHERS  
V. THE SENIOR DIRECTOR GENERAL, GSI, decided on 16.9.1987.  
For the very reasons stated in Ramu's case we make the  
following orders and directions:



We direct the Respondent 1 to consider the and decide the cases of the applicants for regularisation to one or the other post with all such expedition as is possible and in any event, on or before 31.12.1988. But till then, the respondent 1 is directed not to call for fresh applications for selection and make appointments of outsiders in the cadres in which the applicants are working at present.

2. Applications are disposed of in the above terms. But in the circumstances of the cases, we direct the parties to bear their own costs.
