This application having come up for hearing to-day, Hon'ble Vice-Chairman, made the following:-

ORDER

We are sorry that this old matter which is lingering in this Tribunal from 1990 should culminate abortively. The applicant who is a Mateorologist wants promotion to a higher post contending inter alia that his juniors have enjoyed that benefit to his detriment based on a seniority list wrongly drawn up by the Department. Earlier he had joined issue on this very aspect before the Madras Bench of the Central Administrative Tribunal in O.A.No.307 of 1988 where he did succeed. The learned Members of the Madras Bench while disposing off the said application on 21-6-1989 directed consideration of the applicant's case for promotion to the higher cadre along with such of his juniors already promoted by a review DPC etc. etc. and went on to suggest that in case he was found fit, he should be promoted as Meteorologist Grade-I with effect from 11-6-1984. reproduce herein the directions given by the learned Members of the Madras Bench which read as follows:-

"Therefore all the applicants' cases have to be considered along with those of their juniors already promoted by a review DPC to be convened now. Accordingly we direct the first two respondents to convene a DPC to review the cases of the applicants herein for being promoted as Meterologists Grade-I with effect from 11-6-1984 when promotions of several of their juniors were made to the posts of Meteorologist Grade-I as per office order dated 30-5-1984. The process of consideration by the DPC and the issue of orders



thereon should be completed within a period of two months from the date of receipt of copy of the order. In the event of their being found suitable for promotion by the review DPC and orders being issued accordingly, the applicants are entitled to proform seniority in the grade of Meterologist Grade-I with effect from the date on which their juniors were promoted".

Notwithstanding the emphatic fiat issued by the Madras Bench of the Central Administrative Tribunal as aforesaid, unfortunately the applicant not being able to get any relief from the respondents is now before us asking for the very relief sought for and practically obtained at the hands of the Madras Bench. On an appropriate consideration of the decision of the Madras Bench Government issued a communication dated 4-6-1990 (Annexure-A9) stating that his name could not be recommended by the review Board of Assessment for the vacancies of the year 1985 although some of his juniors were recommended for promotion.

2. Be that as it may, we are not going into all those things for the simple reason that by passing the order at Annexure-A9 Government cannot be said to have fully complied with the direction of the Madras Bench under the order referrred to supra. In view of this all that the applicant should do is to file a contempt petition before the Madras Bench suing the respondent in contempt for not obeying the directions of the Tribunal. Such would be the appropriate remedy is also the view of the Full Bench of the Tribunal in C.S.ELIAS AHMED AND OTHERS v. UNION OF INDIA AND OTHERS (Application Nos.451 and 548 of 1991 disposed off on 29-12-1992. Bound as we are by the dicta of the Full Bench, we find it inappropriate to interfere in this matter. We therefore dispose of this application leaving open



all the questions raised herein to enable the applicant, if he still desirous of agitating this matter to take it up before the Madras Bench of the Tribunal in a comtempt petition alleging disobedience with the order of the Tribunal.

With the above observation, this application stands disposed off.
