2. During the course of hearing, learned  
counsel for the respondents has furnished the  
promotion order in respect of the applicants,  
except S.R.Bhosale all others are promoted to  
the post of Class-III post. In the OA, the  
applicants have prayed for seniority and promotion.  
Since the promotion has already been given by the  
respondents, the issue does not survive except in  
case of Bhosale. Regarding the seniority, the  
respondents are directed to show the seniority list  
to the applicants. If they are aggrieved by the  
seniority allotted by the respondents, they are at  
liberty to approach the Tribunal, if so advised.  
Statement made by the learned counsel for the  
respondents that as and when vacancy of Painter  
arises, Bhosale will be promoted to the post of  
Painter according to seniority is taken on record.  
OA. is disposed of in these terms.
