





Mr. Justice P.K.Shyamsundar, Vice-Chairman:-

We have heard both sides and we think it appropriate to direct the respondents/administration to dispose off the representations stated to have been admittedly made by the applicants seeking temporary status. Our attention was drawn to the decision of the Ernakulam Bench of the Central Administrative Tribunal in R.THOMAS AND OTHERS v. UNION OF INDIA AND OTHERS (O.A.No.1821 OF 1992 etc. decided on 5-11-1993) wherein the question of grant of temporary status has been well expounded and a determinative order made. We are told that the said order was later upheld by the Supreme Court in a special leave petition. We take notice of the same. In the circumstances all that we should do and do is to direct the administration to dispose off the representations of the applicants keeping in view the pronouncement of the Ernakulam Bench (supra) within three months' from the date of receipt of a copy of this order.

Applications are disposed off accordingly.
