

O R D E R



1. Although the story told by the applicant appears to be somewhat out of ordinary adverts as it does to the unseemingly behaviour of a male colleague who is also said to be the Union Secretary making attempts in taking undue liberty with her and that she stood firm and declined his unwelcome attention it is alleged that she has been transferred from the post of a stamp vendor to that of postwoman on beat duty in Chickmagalur town. While we do hope that all these unpleasant things the details of which are indeed furnished in the application had not have taken place,

but, however, regret our inability to assist the applicant because it is just the case of a fresh assignment of duties which in this case happens to be reversion to the regular job as Postwoman which event cannot possibly have any cause of action to approach this Tribunal. For the aforesaid reason we hold that this application to be not maintainable.

2. We, however, like to take this opportunity of inviting the attention of the Head of the Department to the allegations made in this application by the lady against one Nanje Gowda and direct the Head of the office to ensure that the lady is not harassed by the unwelcome attentions of the said Nanje Gowda. Let a copy of this order be sent to the Chief Post Master General, Karnataka, for his information and further action. No costs.
