ORDER

Mr. Justice P.K.Shyamsundar, Vice-Chairman:-

After having heard the learned counsel for the applicants, we think it appropriate to direct the applicants to make an apposite representation to the administration concerned highlighting the difficulties in carrying out the responsibilities to be discharged under the impugned order. It is pointed out that without the guidance or assistance of a clerk, it is not possible for the applicants to perform the work of loading and unloading in the transshipment section and there is every likelihood of things going awry without assistance of a clerk. This aspect of the matter was highlighted during the arguments.

We are sure the administration will even now realise the need for continuance of the assistance of a clerk as afforded earlier.

With these observations and with a direction to the applicants to make a proper representation to the administration, we dispose of this application as aforesaid for the present.
