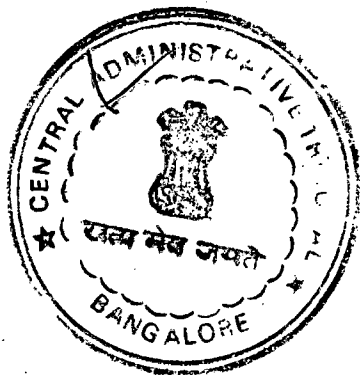

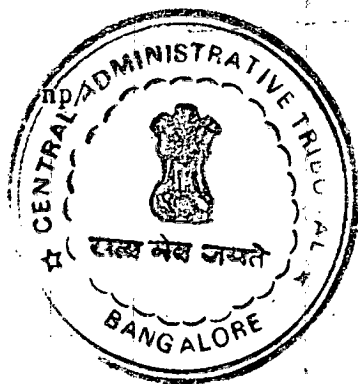


ORDER
