2. Heard both sides at the stage of admission.

All that the applicants want is that they be given the
benefit of the Full Bench ^{Judgment} in O.A. No.395 to 403/1991 and
other connected cases disposed of on 16.12.1993 but then
an intervening circumstance dissuades me from following
the judgement in the Full Bench case referred to supra
because from that Full Bench decision the Railways admittedly
carried the matter to the Hon'ble Supreme Court in SLP
No.5939/94 and the Hon'ble Supreme Court has since stayed
the operation of the judgement of the Full Bench. In
the circumstances all that I should do is, as both sides

agree, that it would be the proper course, to direct that the right of parties shall stand regulated in accordance with the final decision of the Hon'ble Supreme Court in SLP No.5939/94. With this observation this application stands disposed of.
