COUNTER AFFIDAVIT ON BEHALF OF APPLICANT

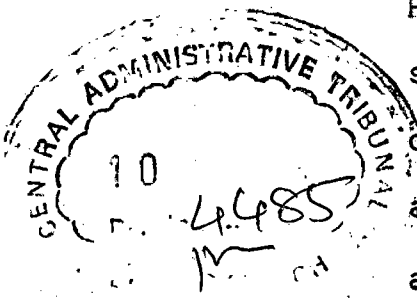
I, Shri Subhash Damodhar Landge do hereby
