O R D E R (ORAL)

(Hon'ble Smt. Lakshmi Swaminathan, Vice Chairman(J)

This OA has been filed on 19/4/94 by Applicant No.1 which is the Madhya Railway Karmachari Sangh and its members (Regd), through its General Secretary, and applicant No.2, an employee of the Central Railway Workshop, Jhansi, praying for, inter alia, quashing of the impugned orders (Annexure A-1 and A-2) passed by the office of the respondents at Jhansi.

2. A preliminary objection has been taken by the learned counsel for the respondents on the question of territorial jurisdiction of this Bench of the Tribunal to adjudicate, on the above impugned orders. However, in view of the Tribunal's order dated 13/2/95, in which the same question of jurisdiction had already been heard and dealt with, the same cannot be re-agitated before another co-ordinate Bench.

3. Shri G.K.Masand, learned counsel for the applicants, Shri S.C.Dhawan, learned counsel for official respondents and Shri V.G.Rege, learned counsel for private respondents Nos.8 to 96 have been heard. The learned counsel for the applicants has relied on the order of Hon'ble Supreme Court dated 12/2/92 in Civil Appeal Nos.642, 642A (Annexure A-7). His main contention is that the respondents have failed to follow the Railway Board's order dated 26/3/90 strictly while passing the impugned orders.

4. Shri S.C.Dhawan, learned counsel has brought to our attention another order of the Hon'ble Supreme Court in a similar matter dealing with the same order dated 26/3/90 passed by the Railway Board, namely, the order dated 30/11/98 in Review

Petition (Civil) 1354-1398/95 in SLP 6451-6501 (copy placed on record). In the order dated 30/11/98, the Apex Court has held as follows:-

The only question involved relates to the inter se seniority of the employees of the petitioner in the Railways. The question is whether the inter-se-seniority is to count with effect from the date when they passed the trade test or with effect from the date they were re-classified. By order dated 12th February, 1992 passed by this Court in Civil Appeal Nos.642-642A of 1992, it was directed that the appeals be disposed of in terms of the decision taken by the Ministry of Railways by its order dated 26th March 1990. This decision of the Ministry of Railways of 26th March, 1990 was to the effect that the seniority will be reckoned with effect from the date of the passing of the trade test. This principle having thus been approved, it is evident that in the present case also, the seniority will have to be recast with effect from the date when the respondents passed their trade test. We order accordingly. We, however, direct that keeping in view the passage of time, the petitioner will neither make recovery of any money from any of the respondents nor revert any of the respondents if that would have been the consequence as a result of recasting of the seniority.

5. Shri G.K.Masand and Shri S.C.Dhawan, learned counsel for the parties, have submitted that applicant No.1, the Madhya Railway Karmachari Sangh and its members, which according to the respondents is not a recognised Union but Registered, consists of employees from other Divisions, other than Mumbai, including Jhansi. In the circumstances, the learned counsel for the official respondents has submitted that as the impugned orders have been issued from Jhansi office of Central Railway, the applicants can only pray for the reliefs in respect of those persons whose names figure in the impugned orders. In other words, he has submitted that applicant no.1 has no cause of

action as no order has been passed by the Central Railway Office at Mumbai so as to affect the rights of that Association at Mumbai. This position has not been disputed by the learned counsel for the applicants. Taking into consideration the relevant facts and circumstances and Tribunal's order dated 13/2/95, the reliefs prayed for in the OA will be confined only to the affected employees in Jhansi Division who have been included in the impugned orders.

6. According to the learned counsel for respondents, the respondents have correctly passed the orders, which have been impugned in this OA, in terms of the aforesaid orders of the Apex Court dated 12/2/92 which has been reiterated/clarified in the subsequent order dated 30/11/98. This position has, however, been disputed by the learned counsel for the applicants. The main grievance of the applicants is that, since they have already passed the trade test prior to revision of their seniority, which has been impugned in the present application, they should neither be reverted nor recoveries made from them by reduction of their pay, as has been done by the respondents. In this regard, it is noticed that the Tribunal vide its order dated 13/2/95, has stayed further recoveries being made from the applicants.

7. In the above facts and circumstances of the case and taking into account the aforesaid judgements of the Hon'ble Supreme Court dated 12/2/92 and 30/11/98, the OA is disposed of with the following directions:-

Respondents, namely, Respondents 1-4 to reconsider the impugned orders dated 4/10/93 and 30/11/92 Annexures A-1 & A-2) in the light of the Supreme Court orders (supra) and pass appropriate orders, including, quashing of the aforesaid orders, if necessary, to ensure that they have fully complied with the directions of the Hon'ble Supreme Court in terms of the letter dated 26/3/1990. They may pass such order as expeditiously as possible with intimation to Applicant No.1. No order as to costs.
