O R D E R (ORAL)

Smt. Shanta Shastry.

This OA is about the selection for the post of Assistant Teacher/Primary Teacher in the Administration of Daman and Diu, held on 14th October, 1992. The applicants along with the private respondents appeared for the selection, but did not succeed. The respondents No. 8 to 55 were selected vide order dated 5.12.94. In this OA, the applicants have challenged the aforesaid selection of the respondents 8 to 55 and non-selection of the applicants.

2. There are, in all 25 applicants, who have filed this application. However, we do not find any MP seeking permission to file a joint application under Rule 4 (5) of the CAT (Procedure) Rules, 1987.

3. Further, when the matter was taken up for final hearing, the learned counsel for the respondents Shri R.R. Shetty produces an affidavit dated 30th July, 2001 sworn by applicant No.1, Shri Dilip Kumar Patel. The same is taken on record. The applicant No.1 has stated in this affidavit that he had appeared for selection and had not got through the selection and had approached this Tribunal with a grievance. He now, has been appointed as Primary Teacher in the Administration of Daman & Diu, on 17th August, 1998 and being satisfied, he does not want to pursue the OA further and therefore,

would like to withdraw the same with immediate effect. He also stated that he would undertake to inform all the co-applicants and assures that none of them will object to this affidavit. The applicant had taken leave of the other 24 applicants. Further, the learned counsel for the applicants also submits that the other applicants have not contacted him for quite some time.

4. In view of the fact that the applicant No.1 wishes to withdraw the application and there is no M.P. for joining of other applicants, the OA deserves to be dismissed on this ground alone.

5. On merits, the learned counsel for the applicants submits that the selection was not made properly as some of the respondents out of the respondents 8 to 55 had obtained a caste certificate in Daman & Diu, based on a caste certificate issued by Government of Gujarat. They were rank outsiders and therefore, they should not have been selected.

6. The learned counsel for the respondents, however, contends that the selected candidates have fulfilled the requisite condition of six months' domicile in Daman & Diu and therefore, there is no flaw in the

selection procedure. Further, all these applicants appeared in the selection, waited for the results to come and having failed, they have approached the Tribunal now. Having failed in the selection, the applicants cannot make a grievance of it now. The learned counsel for the respondents relies <sup>on</sup> Madanlal & Others Vs. State of J & K (1995 (2) SLR 209) wherein, it has been held that once the candidate had taken a chance of appearing in the selection, he cannot challenge the validity of the same, especially after the candidate has failed. We are bound by the judgment of the Supreme Court and the same applies fully in the facts and circumstances of the present case also.

5. In the facts and circumstances of the case, the application fails both on procedural <sup>law</sup> ~~law~~ as well as on substantial law. No costs.
