

ORDER (ORAL)

Per: Kuldip Singh, Member (J):

The Applicant is aggrieved by the Order dated 3.2.1995
whereby the Applicant has been called upon to appear for an
Aptitude test for the post of Console Operator in the Grade
of Rs.1600/- -- Rs.2660/- (RPS). Though in the Original
Application the applicant has sought multiple reliefs, the

Applicant now concentrates on one issue that since he has already qualified the Aptitude Test for the post of Console Operator, he should not be called upon to appear for the Test again. To support his contentions, the Applicant stated that the earlier Test was conducted on 20.6.1993 and the Applicant was declared qualified in the same with Grade B vide letter dated 8.4.1993 wherein it was mentioned that only those who have secured Grade A & B shall be considered to have passed the Aptitude Test and they will be considered for the purpose of Console Operator as and when the post becomes available.

2. As per the Rule position for the post of Console Operator, the Counsel for the Applicant submits that the Department wants to conduct fresh Aptitude Test for the post of Console Operator and the Applicant cannot be asked to appear for the Test again since the Applicant has already passed the same and the result of which was declared in April, 1993.

3. We have heard the arguments. The Department has already intimated the Applicant vide its letter dated 8.4.1993 that he had passed the Aptitude Test and Secured the B Grade. In view of this stated position, the Department cannot call upon the Applicant to appear in the Test again. Applicant has already qualified the Aptitude Test and secured Grade B.

4. Hence we direct the Respondents/Department that the Applicant be considered for the post of Console Operator as and when the vacant post is available without passing a
