

1. In this application, the applicants ^{who} are working as Head Cooks/senior Cooks ^{have} challenged the action of the Railway Administration in not giving them opportunity for being considered for promotion to the post of Catering Inspector. The official respondents and some of the private respondents have filed their reply opposing the application. We have heard both sides.

The applicants' case is that Senior Cooks/Head Cooks ^{have} ^{now} no avenue of promotion and then the new channel of promotion was created by Railway Administration as per letter dated 3/12/97 enabling the applicants for being considered for promotion to the post of Catering Inspector Grade-II. As per this letter 20% of the vacancies to be earmarked from the cadre of Head Cooks. But when the administration took up the action for ^{consideration}, Head Cooks were not considered. The applicants are challenging the action of the Railway Administration.

2. The stand of the official respondents and the private respondents is that a decision taken as conveyed in the letter dated 3/12/97 has been subsequently modified and reviewed after consulting with the two Railway Unions and fresh instructions ^{have} been given as per letter dated



6/4/98. ^{There} It is however the case that Head Cooks are not only stagnating in the present post and they have been given one more avenue of promotion on the recommendation of the 5th pay commission and necessary order has been issued which is dated 10/5/98.

3. After hearing both the sides and perusal of the records, we find that the earlier decision of the Railway Administration as per letter dated 3/12/97 that the Head Cooks should be given a chance of 20% ^{promotion} to the grade of Catering Inspector Grade-II was reviewed and changed subsequently after consulting both the unions. As per papers produced by learned counsel for official respondents said this decision to review the earlier ^{took place} order within 15 days after 3/12/97. But a second notification has been issued on 6/4/98 and as per that letter the previous letter dated 3/12/97 has been reviewed and the direction is given ^{that} promotion to be done as per the existing avenue of promotion. In view of this letter, the earlier decision conveyed in letter dated 3/12/97 has been reviewed and therefore the applicants cannot claim any rights in the light of letter dated 3/12/97. The stand has been further clarified vide letter dated 10/5/98 which is issued on the basis of the 5th pay commission report providing one more avenue of promotion to Head Cooks as Master Cooks equivalent to Catering Inspector Grade-II.

4. In these circumstances, we find that the applicants have no case ~~or~~ to admit the application or to continue the exparte Interim Order. The earlier granted exparte Interim Order and subsequently modified Interim Order is hereby vacated.

5. In the result, OA is disposed of at the admission stage with no orders as to costs.
