

The applicants who are Departmental Promotees as Diesel Assistant in Nagpur Division of Central Railway have filed the present OA challenging the Provisional Seniority List dated 18/11/97 where they have been shown as Junior to Direct Recruits with a prayer to stay the operation of this seniority list and direct the respondents to give promotions on the basis

of confirmed and final seniority list dated 7/2/1994.

3. The official respondents as well as private respondents have filed written statement. There is a subsequent development after filing of this OA on 12/3/98 with regard to the seniority of the applicants. The learned counsel for applicants submits that the respondents have issued letter dated ^{wherein} 6/1/98 it is laid down that promotees would be restored ^m ~~wherein~~ back to their seniority from the date of promotion above direct recruits and thereby the seniority list dated 7/2/92 has been restored. In view of this development, the counsel for applicant submits that the OA has become infructuous.

4. In view of the above submission, the OA stands disposed of accordingly. No orders as to costs.
