MEMBER (JUDL.)


The applicant herein, an Excise Sepoy in the Central Excise Collectorate, Guntur, has filed this application .. questioning the order No.C.No. II/10-A/29/78-Vig. dated 24.12.79 passed by the 1st respondent, compulsorily retiring him from service after framing charges for absenting himself from duty on various dates. The application has been filed raising various contentions and grounds including the ground that the punishment is excessive.


