

The applicants in all these cases are Casual Mazdoors in the Telecom Department, A.P. Circle. Their common grievance is that their services have been terminated by oral orders without giving them any notice. As common issues are involved, we are disposing of all these applications by a common order.

2. The main argument advanced on behalf of applicants by their learned counsel Shri C. Suryanarayana is that they were all recruited as Casual Labour under the various units of the Telecom Department and all the applicants have worked continuously for more than 240 days in a year. According to the orders in memo No. 269-69/88-STN dated 17-10-1988 issued by the Director General, Telecom, New Delhi, a combined seniority list of Casual Mazdoors has to be maintained. The said list will contain all Casual Mazdoors working within the territorial jurisdiction of the recruitment unit, for various functional units such as Telecom Projects/Maintenance regions/Electrification/Quality Assurance etc., to which they are attached. Absorption of Casual Labourers against regular group 'D' post or retrenchment due to exigencies such as non-availability of work, will be done strictly according to the combined seniority list. Further instructions have been issued in D.G., Telecom, New Delhi order No. 269-29/88-STN dated 18-11-1988 directing that these casual mazdoors who have completed seven years of

service by 31-3-1987 will be absorbed as Class-IV employees. As per Director of Telecommunications letter No.269-10/89-STN dated 7-11-1989 and clarifications issued in memo even No. dated 17-12-1990, it was directed temporary services is accorded to the casual mazdoors who have completed 240 days of service in a year or more. The respondents have not implemented these directions.

3. Shei Suryanarayana further stated that he is limiting the relief asked for to the issue of a direction to the respondents to prepare a seniority list of casual mazdoors of the telecom district as on 1st April of every year within a time to be specified by the Tribunal and to engage the applicants in accordance with the position in the seniority subject to the availability of work. He also seeks that the respondents be directed to give temporary status as per the instructions in D.G.Telecom's letter dt.7-11-1989. He further states that the applicants are withdrawing the relief they had claimed under the provisions of the Industrial Disputes Act, 1947.

4. We have heard Shri C.Suryanarayana, learned counsel for the applicants and Shri E.Maden Mohan Rao, and Shri Naram Bhaskar Rao, learned standing counsels for the Respondents. We find considerable merits in the submissions made by Shri Suryanarayana and accordingly direct the respondents to prepare the seniority list as per the various instructions issued by the D.G.Telecom letters viz.,

- (1) D.G.Telecom letter No.269-89/88-STN dated 17-10-1988
- (2) D.G.Telecom letter No.269-29/88-STN dated 18-11-1988
- (3) D.G.Telecom letter No.269-10/89-STN dated 7-11-1989
- (4) D.G.Telecom letter No.269-10/89-STN dated 17-12-1990.

The respondents are also directed to re-engage the applicants in accordance with their seniority subject to the availability of work and also to extend such other benefits as per D.G.s letters issued from time to time taking into consideration the Judgments of the Supreme Court, after preparing the seniority list/confirmation of temporary status as per the above circulars.

5. Shri Suryanarayana apprehends that the benefit of regularisation in terms of the various instructions issued by the Director General P&T is unlikely to be extended to those casual labourers who were recruited after 30-3-85. His apprehension is unfounded. The Supreme Court had in Ramgopal & others Vs. Union of India and others in WD (C) No.1280/89 etc. and in Daily Rated Casual Labour in P&T (AIR 1987 SC 2342) directed that the casual labourers who had put in 240 days service in one year's service should be regularised in accordance with a scheme to be worked out by the Departments. Subsequently the Supreme Court in Ramgopal & others Vs. Union of India & others in WD (C) No.1280/89 etc., directed that the respondents shall prepare a scheme on a rational basis for absorbing as far as *** ****.

practicable, the casual labours who have continuously worked for more than one year in the Telecom Department and this should be done within six months from now. The Supreme Court has also observed that no distinction can be drawn between the petitioners as a class of employees and those who were recruited and employed before the Supreme Court's order in the AIR 1987 SC 2342 and that on principle the benefit of the decision in AIR 1987 SC 2342 must be taken to apply even^{to} those who were recruited after 30-3-1985.

6. Shri Suryanarayana further states that in some of the O.A.s viz., O.A. Nos. 60/89, 310/89, 314/89, 315/89, 429/89, 519/89, 521/89, 585/89, 101/89, 167/89, 241/90, 262/90, 263/90, 342/90, 372/90, 373/90, 630/90, 701/90, 705/90, 706/90, 782/90, 783/90, 784/90, 785/90, 787/90, 788/90, 789/90, 790/90, 820/90, there were breaks in service due to non-availability of work/sickness etc. He states that the various authorities competent to condone the break in service have not followed the instructions issued by the D.G.P & T in circular dt. 10-10-1980 in No. 28-11/77-SR/STN, wherein it has been laid down that the absence of more than six months may be condoned by a Divisional Engineer on one of the two grounds i.e. illness and non-availability of work. He therefore seeks that the respondents be directed to pass orders on the condonation of breaks in service in accordance with these directions. In regard to the point raised on the

breaks in service we direct the respondents to pass the orders in accordance with the instructions issued by the DGP & T referred to above and such other instructions as ^{been} have/ issued from time to time. Sri Suryanarayana has contended that in O.A.Nos.161/90, 231/90, 228/90 and 675/90 ~~the applicants have contended~~ that despite there being no break in service, the service of the applicants have been terminated. It is open to the applicants in these cases to make a representation in this regard to the competent authority, who will pass appropriate orders in regard to the said representation. If the applicants are aggrieved there^{by} it is open to them to seek appropriate remedies.

7. Sri Suryanarayana has contended that ~~the applicants~~ in O.A.Nos.490/88, 2/89, 3/89, 105/89, 347/89, 624/89, 839/89, 160/90, 263/90, 296/90, 298/90, 342/90, 399/90, 725/90, (781/90), 860/89, 262/90, either all or some of the applicants belong to SC/ST community, and in their cases rule of reservation will have to be followed. The applicants in those cases will make representations to the respondents ^{duly} submitting their claim to SC/ST status. If they are able to establish that they belong to these communities they will be re-engaged in preference to the OC candidates in accordance with the rule of reservation.


8. Finally Shri Suryanarayana contends that the applicants are entitled to back-wages from the date of termination. He has cited several decisions in support of this contention i.e.



In all these cases the courts had specifically held that the termination was illegal. In the present cases before us we have not held that the termination is per-se illegal. We have in the present applications only gone into the question whether the applicants are entitled to regularisation/ grant of temporary status on the basis of the instructions issued by the Director General, Telecom and in terms of the Supreme Court decisions. The question whether their termination is contrary to the Industrial Disputes Act has not been pressed before us as already indicated earlier. The question whether an order of termination of a worker is illegal on the ground that there has been violation of I.D. Act has to normally be raised by way of an Industrial dispute before the Industrial Tribunal. This is the purport of the Larger Bench decision of this Tribunal in 1991 (1) SLR 245. Hence if the applicants were aggrieved by the orders of termination they ought to and should have been raised an Industrial Dispute. It is in these circumstances that the counsel for the applicants did not (and in our view

rightly so) press the questions as to legality of the termination vis-a-vis the provisions of the I.D. Act. Since we have not gone into the question whether orders of termination are illegal the question of granting back wages does not arise. However it is open to the individual workmen to question the individual orders/action of the respondents in terminating their services before the Labour Court if such a remedy is available to them. The question of payment of back wages would be dependent upon a decision if any in such a proceeding.


9. With these directions the original applications are allowed to the extent indicated above. There will be no order as to costs.
