

the personnel so appointed against the temporary posts would be retrenched due to reduction in establishment consequent on the completion of the schemes. The Government also relaxed conditions of Recruitment Rules for making appointments against the Temporary posts and to fill up the posts through the permissible channels like through Staff Selection Commission/Employment Exchanges etc. It is submitted that the posts which continues beyond the main Census period will have to be filled up on regular basis in accordance with the statutory recruitment rules notified for various posts.

5. It is submitted that the post of Computer in the pay scale of Rs.1200-2040 is a Group-C Non-Ministerial (Technical) post. As per statutory Recruitment Rules notified for the said post in the Gazette of India Issue dt. 22.12.1973, the method of recruitment was by promotion 50%; transfer 25% and direct recruitment 25%. Assistant Compiler in the pay scale of Rs.110-180 (pre-revised) with three years regular service were eligible for promotion. For direct recruitment candidates possessing degree of a recognised university with Mathematics or Economics as a subject of Graduation were eligible. The said Recruitment Rules were amended in 1979 vide Registrar General's notification No.3/3/78-Ad.I dt.9.4.79. According to the amended rules, there was no provision in Recruitment Rules for direct recruitment to the post of Computer. The method of recruitment was by promotion 75% and the remaining 25% by transfer failing which by promotion. However, during 1984 the common recruitment rules for the post of Computer in respect of the office of the Registrar General, India as well as all the offices of the Director of Census
