THE TRIBUNAL MADE THE FOLLOWING ORDER:-

The applicant herein who is a senior observer, in the office of the 1st respondent, has been transferred and posted to Cyclone Detection Radar Station Dolphin's Nose, Visakhapatnam under order No.CUC-STF/543, dated 15-2-90. It is this order which is sought to be impugned by the applicant. Various grounds have been urged by the applicant in support of his contention that he should not be transferred when he is not qualified for the post to which he is transferred.

We have heard the learned counsel for the applicant and ~~Shri~~ N.Bhaskar Rao, Addl.Standing counsel for the department.
