The Tribunal made the following order:-

In this application the prayer is to direct the respondents to restore the seniority of the two applicants as shown in the gradation list published in 1988. The impugned gradation list is the one circular issued by the 3rd respondent in his proceedings dated 5.7.89. In this impugned seniority list the 4th respondent shown at S1 No.1 and the applicants are shown at S1. No.24 and 25, whereas in the earlier seniority list the applicants were at S1. No.3 and 4 whereas the 4th respondent was shown at s1.No.25. Shri Naveen Rao, counsel for the applicant drew our attention to the counter filed by the Respondents. It has been admitted by the Respondents that the list circulated by the 3rd Respondent was a mistake and that the 3rd respondent was instructed to rectify the mistake and restore the original seniority to the applicants. Shri. N.V.Ramana, learned counsel for the respondents did not oppose this and in view of this position we direct the respondents to revise the seniority list in accordance with their statement at para-4 of their counter within a period of three months from the date of receipt of this order. ✓

2. Application is accordingly disposed-of with the above direction. No order as to costs. ✓

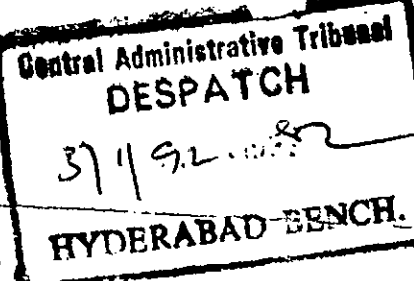
