This review petition has been filed by Shri P.Seetharam and 34 others against the Chief General Manager, Telecommunications, A.P.Circle, Door Sanchar Bhavan, Station Road, Hyderabad and 2 others, seeking a revision of the orders not admitting the O.A.No.867/91 through the orders contained in M.A.No.1072/91 thereon. In the M.A. referred to I have held that sufficient case for condonation of delay in filing the O.A. was not made out and hence dismissed the M.A. No.1072/91. Since the delay in filing the O.A. was not condoned the O.A. was hit by limitation and hence not admitted. In the review petition no apparent error has been pointed out and no new material which was not available at that time has also been brought forth. Hence the review petition is dismissed.

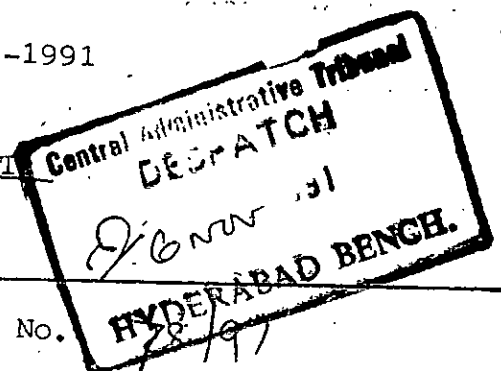
