



4. We have heard Shri K. Nageshwara Reddy, learned and counsel for the applicant/ Shri Naram Bhaskar Rao, learned standing counsel for the Respondents 1 and 2. On a consideration of the averments made in the application, we direct that if the seven persons namely (1) Hari Philip (2) M. Krishna (3) Ch. Pandu (4) Kewal Singh (5) Tejender Singh (6) S. Deep Singh (7) T. Ramulu are juniors to the applicants in their own category then the names of the applicants also should be considered by the Respondents for the written test/interview to the posts of Helper/Watchman/Attender.
