This application is filed by Sri Narasimha S/o Mallaiah and 49 others against the General Manager, South Central Railway, Secunderabad and 6 others. Infact the prayer in this application is to direct the Respondents to correct the revised seniority list dt.14-8-91 and to fix the seniority of the applicants on the basis of the dates on which they attained temporary status. The applicants relied on a judgment of this Tribunal passed in DA 89/89.

2. Respondents have filed a counter opposing the application vehemently on the grounds that their code Rules have not been modified and that the applicants are not parties to the earlier cases decided by this Tribunal.

3. We have examined the case and heard the counsel for both sides. The two objections raised by Sri N.R.Devraj, learned counsel for the Respondents can be easily over-ruled. It is settled law that the judgment given in one case shall be

equally extended to all similarly placed persons. It is also

not disputed that the decision in O.A.89/89 applies to this

The Code provisions are subject to the Judicial decision.
 case. Such being the position we give the same directions to

the Respondents in this case as in the case of OA 89/89.

Accordingly we direct the Respondents to fix the seniority of
 the applicants ~~reckoning the date of Temporary Status as the~~

criteria. With the above directions the application is

disposed-of with no order as to costs. The Respondents shall

carry out this exercise within a period of four months from

the date of receipt of this order. No order as to costs.
