The Tribunal made the following Order:-

Heard both the learned counsel.

Admit. The learned counsel for the applicant has drawn attention to an order dated 13-4-94 in O.A.440/94 wherein the applicants were given certain Interim relief. The contention of the counsel for the applicant is that the applicants in the present OA are similarly situated as those in OA 440/94.

The applicants in the present OA are those who are working as First Fireman/Diesel Assistants under the Respondents. Consequently, we find that the applicants herein should also be given similar interim relief as given to those in OA 440/94. Accordingly, we pass the following interim order for consideration for promotion to the post of Shunter:  
The cases of respondents 4 to 93 should not be considered for promotion to the posts of Shunters till cases of such of the promotees to the post of First Fireman who were eligible for consideration for promotion to the post of First Fireman by 30th May, 1989 are considered. This interim order will be subject to the result in this OA."
