


I Judgement as per Hon'ble Shri R.Balasubramanian,

Tribunal in O.A.No.20/92.


2. When the case was heard it was brought to our attention
that a Review Petition No.30/92 in O.A.No.1132/91 had
already decided upon on 17.3.92. The order dt. 13.1.92
in O.A.No.20/92 is based entirely on the order dt. 19.12.91
in O.A.No.1132/91. We have seen the Review Petition
No.30/92 filed in O.A.No.1132/91. The Review Petition
No.30/92 which sought for a review of the judgement

dt. 19.12.91 in O.A.No.1132/91 was dismissed by our order dt. 17.3.92 in that review petition. On a scrutiny we find that the grounds in this review petition are exactly the same as the ones raised in the Review Petition No.30/92 which ^{was} is decided. The O.A. sought to be reviewed was based on O.A.No.1132/91 wherein the review was dismissed. Hence, on the same grounds, we dismiss this review petition also, where the points raised are the same as in the dismissed review petition No.30/92 in O.A. No.1132/91, with no order as to costs.
