We have heard Shri S.Ramakrishna Rao, learned counsel for the applicant and Shri N.V.Ramana, learned counsel for the Respondents. This application is filed by the applicant to direct the 1st Respondent to allow the applicant to cross the efficiency bar with effect from 1-6-1988 with all consequential benefits. The facts averred in the Original Application would disclose that the applicant herein had submitted representation on 11-8-1988 and another on 15-1-1991 followed by another representation dt.15-10-91. The Respondents do not appear to have decided any of the representations preferred by the applicant. Hence we are of the opinion that it would

be just and fair to dispose of this O.A. by giving proper directions to the Respondents.

2. In the result we direct the Respondents to finally dispose of the representations dt. 11-8-88, 15-1-91 and 15-10-91 within two months from the date of receipt of this order. If the applicant continues to be aggrieved by the decision of the Respondents, he would be at liberty to approach this Tribunal afresh.. With the above directions we dispose-of the O.A. at the admission stage itself with no order as to costs.
