Pursuant to the order dated 4.12.91 in
OA 671/89, the applicant has been placed under deemed
suspension from 3.8.89 vide orders in Letter No.
24(5)(3)/92-G-123 dated 12.8.92 passed by the Sta-
tion Director, AIR, Cuddapah. But the applicant
has not been paid any subsistence allowance pursuant
to the above order. The applicant has represented
to the Station Director, A.I.R., Cuddapah on 3.9.92
seeking among other benefits, the subsistence
allowance to which he is fully entitled. Not having

received any subsistence allowance or reply, the applicant has approached this Tribunal with this OA wherein he has prayed for a direction to the respondents to pay the subsistence allowance from 3-8-89 to 3-9-92 and impliedly full salary from 4-9-92.

Under these circumstances, I direct the respondents to take a decision on the representation dated 3-9-92 made by the applicant and pending before them within one month from the date of receipt of this letter. If the applicant is still aggrieved by the final orders passed, he is at liberty to approach this Tribunal.

With the above direction I dispose of this OA with no order as to costs.

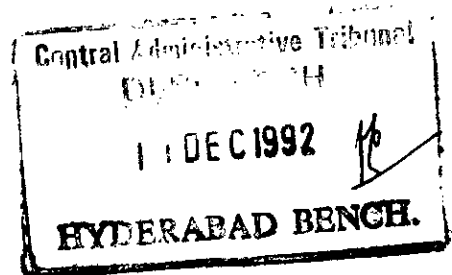
