OA 107/92 is filed by Mr. P.Veerabhadraiah with a prayer to order fixation of permanent pension on par with Mr. M.Mastan Rao who retired as a Station Master at Donakonda and who is the junior in service to the applicant and to order payment of commutation amount and also the amount payable under the Insurance scheme.


2. Heard Mr. M.Lakshmana Murthy, learned counsel for the applicant and Mr. Rajeswara Rao on behalf of Mr. D.Gopal Rao, Standing Counsel for the respondents. By the orders dated 9.2.1989 in TA 6/88, this Bench had directed the respondents to pass suitable orders regarding pension according to law. By a seperate order passed today in MA 435/92 in TA 6/88, we had directed the respondents to pass suitable orders according to law regarding pension payable to the applicant within a period of three months from the date of receipt of ~~that~~^{the} order in the MA. In view of the said orders passed in the MA 435/92 in TA 6/88, the learned counsel Mr. M. Lakshmana Murthy appearing for the applicant stated that he is not pressing this OA. 
we dismiss this OA at the admission stage itself as not pressed. There is no order as to costs.


