JUDGMENT OF THE DIVISION BENCH DELIVERED BY THE HON'BLE  
Mr. Justice V.NEELADRI RAO, VICE CHAIRMAN

The applicant is now <sup>through</sup> working as LSG/Postal Assistant. His contention is that <sup>he</sup> completed 30 years of service as on 1.10.1991 and his name was not included in the list of promotees dated 6.1.1992 that was prepared on the basis of Bi-ennial Cadre Review and then he submitted a representation on 24.1.1992. But, instead of considering his representation, a charge memo dated 10.4.1992 was issued and after enquiry one increment was withheld for a period of one year. It is urged for the petitioner that, as no disciplinary proceeding was pending as against the applicant as on 1.10.1991, the due date by which he was entitled to promotion, the concerned was not justified in not ordering promotion and the subsequent disciplinary proceeding is not relevant for consideration of his promotion as on 1.10.1991.

It is also submitted that the representation of the applicant dated 24.1.1992 is not yet disposed of. We feel that instead of considering the matter on merits,
