8. He should make family planning propaganda work among men folk.

9. He should look to the clearliness of all residential and non-residential buildings of this Organisation.

10. He should visit the Boarding Homes and Midday Meal Centres often to see whether meals are served neatly and properly.

11. He should help in the supervision and construction wells by issuing certificates as regards the potability of the water tapped and to the hygienic condition of the site in which the well is proposed to be sunk.

12. He should organise meeting etc., during the Health week celebrations and also at the time of any gathering in mining area.

13. He should maintain close liaison with the Heads of Institutions, projector-operator, Health Inspector of the Rapur Samithi and Rapur Range.

14. The Health Inspector should maintain the following registers etc.

- (a) Stock ledger for all furniture, equipment, and other material received.
- (b) A village visiting roster.
- (c) Fortnightly diary.
- (d) Advance fortnightly tour programme.
- (e) Personal Register and periodical register.

15. The Health Inspector has to attend to all the correspondence relating to this branch of work.

16. He has to submit daily reports in case of any out-break of epidemic like small pox cholera etc.

17. He should attend to any other work assigned by M.Os., or the Secretary and Chairman of the Fund from time to time.

18. He should work under the administrative Control of the Asst. Surgeon, Base Hospital, Kalichedu. His office will be located in the premises of Base Hospital, Kalichedu.

w.e.f. 01-01-1986 by an Office Order Dated:28.10.1986. As per the A.T. Act, the maximum only one and half year from that date is allowed. Once the pay is fixed, the date of such fixation is only the cause of action and it is crucial for calculating the limitation i.e. from 01-07-1987 and the Office Memorandum Dated:1-10-1990 which is filed by the applicant is only clarification and this date cannot be counted for limitation. Hence the O.A. is barred by limitation.

3. It is submitted that it is true that the applicant has passed the Matriculation Examination and undergone Sanitary Inspector's Training. He was appointed as Health Inspector in the respondent's office vide this office RC.A.No.256/65 Dated:31.8.65 on a scale of pay of Rs.130-5-175-6-205-7-212. He joined the duty on 2.9.65 F.N. The same scale was continued till the date of implementation of Third Pay Commission w.e.f.1.1.1973. The averment of the applicant that his pay was fixed in the scale of pay of Rs.150-240 is not true and hence denied.

4. It is further submitted that the Health Inspector was discussed among other Posts under Para 85 - 'X. Para Medical Staff' in Third Pay Commission Report and as such the scale of pay of Rs.330 - 560 was implemented to the Health Inspector as in the case of other para-medical staff viz., Pharmacists, Radiographers as recommended by Third Pay Commission and the same was implemented w.e.f.1-1-1973 vide
