The Tribunal made the following order:-

In this case M.A.NO.292/92 has been filed for both the applicants to file a single application. On the explanation of the learned counsel for the respondents the Bench is satisfied and hence M.A.NO. 292/92 in O.A.NO.212/92 is allowed.

When this case was taken up for admission, hearing today, Sri T.Jayant, learned counsel for the applicants stated that this case is already covered by a judgement dated 23.6.1989 of this Bench in O.A.NO.363/88. On the other hand, Sri. N.Bhaskara Rao, learned counsel for the respondents, drew our attention to annexure A.12 (material paper 22 of the application) which is an order No.ERDL/IND/3340/R/3 dated 6.12.91 issued by the Director, ERDL addressed to the officer-in-charge, ERDL Cell, Hyderabad. It is stated in the letter that the cases of the applicants had already been taken up with R&D Headquarters and their decision is awaited. After careful consideration this Bench thinks it fit to direct the respondents to take a decision on this question and inform the applicants on or before 30.6.92. If after the decision is conveyed to the applicants they are still aggrieved, they are at liberty to file a fresh O.A.

With the above direction, this OA is disposed of with no order as to costs.
