Sri P.Krishna Reddy, learned counsel for the applicants states that the impugned order dated 25.3.1992 is a reversal of the earlier seniority list dated 28.8.1989 without notice. He also points out that the applicants have submitted representation dated 8.4.1992 to the Senior Divisional Personnel Officer, SC Railway, Vijayawada. It is also alleged that in the meantime the Respondents have stopped engaging the applicants. Sri N.V.Ramana, heard for the Respondents.

2. After hearing both the counsels, we direct the respondents to dispose of the representation dated 8.4.1992 within a reasonable time and till the disposal of the representation dated 8.4.1992 by the respondents, the applicants shall be continued to be engaged based on the original seniority list dated 28.8.1989. With the above directions we dispose of the application with no order as to costs at the admission stage itself. The applicants are however at liberty to approach us if they are not satisfied with the disposal of their representation dated 28.8.1989.

3. In view of the directions given in the O.A., the M.A.442/92 in O.A.NO.321/92 is dismissed as unnecessary.
