Subbarayudu, praying for a direction to the Respondents to set aside the Employment Notice No.1/91 in letter No.TR/P.Con/Rec/Gr.'D' dated 17-6-91 and Notice No.TR/P.Rec/Gr'D' dated 18-6-1991, and to direct the respondents to appoint the applicant as Skilled Artisan in the scale of Rs.950-1500 in CRS, Tirupathi, pursuant to the panel dated 21-3-1987.

2. When the case was taken up for admission hearing Ms. Babita Rayudu pointed out that this is fully covered by our decision dated 19-12-1991 in OA.1056/91. Shri N.V. Ramana is heard on behalf of the Railways.





3. Since this subject is covered by OA.1056/91, we dispose of this application at the admission stage itself with the same direction given in OA.1056/91 viz.

"The respondents are directed that as and when the Group 'D' posts in the outsiders quota become available at Carriage Repair Shop, Tirupathi or anywhere else in the Guntakal Division, the applicant should be considered first before considering any other case in the order of their rank in the empanelment for Group ' ' Posts."
