

When the case was called, it was pointed out to us by Shri N.R. Devaraj that all the Applicants are not similarly placed, in that only Applicant No.1 had chosen to represent and that too not to the competent authority, only on 13-7-1992.

2. Shri D. Ramakrishna, however, produced a copy of the letter dated 13-8-1992 in reply to the representation dated 13-7-1992 and pleaded that this is the cause of action. But this disposal is subsequent to the filing of the OA. It is now clear that the OA is premature and is liable to be dismissed as such.

3. The applicants are at liberty to make suitable representations and the respondents are directed to pass final orders on such representations within a reasonable time. If the applicants are still aggrieved with the final orders passed by the respondents, they will be at liberty to approach this Tribunal with fresh OA.

4. With the above direction this OA is dismissed with no order as to costs.
