Heard Sri G. Ramachandra Rao, learned counsel for the applicants and S/Sri V. Bhimanna, M. Panduranga Rao, and N. Ram Mohan Rao, for the respondents.

2. For filling up vacancies of Fireman Grade A, the Railway Board had issued instructions in their letter No.EG II-80/RC-1/144, dated 30-4-1982. As per these instructions the vacancies of

of Fireman Grade A were to be filled as under :

- a) Fifty per cent by the usual selection procedure from Fireman-B who have studied upto 8th Class and are below 45 years of age;
- b) Fifty percent by a Departmental examination from all Fireman Grade B and Grade C who are matriculates and have three years Railway Service; and
- c) If the Departmental examination fails to provide enough matriculates for the 50% quota, direct recruitment to be made through the Railway Service Commission.

3. In the scales of pay notified under recommendations of the IV Pay Commission, the Grades of Fireman A & B have been merged and placed under a single scale of Rs.950-1500 and the posts in the merged scale ~~is~~ redesignated as First Firemen. The post in the erstwhile Fireman Grade-C were allotted a single revised scale of Rs.825-1200 and ^{were} ~~was~~ designated as Second Firemen.

4. Waltair Division of South Eastern Railway initiated selection for filling up the posts of Fireman Grade I some time in August, 1987. The total of 88 vacancies was assessed as existing and anticipated upto 15-10-1987 in the Grade of First Firemen. Out of these, 44 posts were reserved for being filled up from amongst the regular Second Fireman in the scale of Rs.825-1200 who had studied upto 8th class and were below 45 years of age. The remaining 44 vacancies were reserved for being filled up from amongst the matriculates working as Second Firemen and who had put in a minimum of three years service. After holding the examination etc. against the 50% quota for those who had studied 8th class and below 45 years, a part-panel of 34 names was published on 18-7-1987. This was followed by inclusion of another 10 names

in the final panel which carried a total of 44 candidates. The final panel was published on 16-5-1988. It is also stated that for this mode of selection a total of 83 eligible candidates were considered.

5. With regard to remaining 50% to be filled from Matriculates with minimum three years service, a provisional panel was ^{initially} ~~finally~~ published on 9-3-88 containing 17 names and that was followed by a further list of 14 names and the final panel issued on 16-5-1988 contained a total of 31 candidates.

6. In these panels the names of the applicants are not included and aggrieved by this, this OA has been filed claiming the following reliefs :

- i) quash the impugned letter No.WPV:MR:18/I FM:PtIII dated 26-11-1991 (by which the administration justified the formation of the panels)
- ii) declare the panels formed for promotion to the posts of I Firemen empanelling 44 non matriculate Fireman published under DPO Waltair's No.WPV:MR:IFM:Pt.3/Conf. dated 18-12-87 and consisting 34 names, and further panel published under No.WPV:MR:18/I FM:Pt.3/Con. dated 16-5-1988 containing 10 names as irregular and set aside them, and also
- iii) declare the panels formed for promotion to the posts of I Fireman empanelling 17 matriculate II Fireman published under DPO Waltair's No.12/11/Staff/I/I FM: Pt.III/Conf, dated 9-3-1988 and panel published under DPO Waltair's No. 12/11/Staff I/I FM/Pt.3/Conf, dated 15-5-1988 in which 14 matriculate candidates were included totalling to 31 as irregular and set aside them; and
- iv) direct the official respondents to draw a panel of First Fireman from amongst II Fireman who have qualified in the selections of 1987, 88 and subsequent panel of 1989

and arrange the names according to the interse seniority of II Fireman as it stood prior to 15-10-1987, the date of DPO's circular for selection and also

v) direct the official respondents to fix the pay of those empanelled Fireman in the combined panel from the date their juniors are promoted as First Fireman on the basis of earlier selections and also order payment of the arrears of pay and allowances to such of the eligible candidates who should have been considered for empanelment in the selections held in 1987/88 as per Board's letter dated 3-11-1987 and CPO's letter dated 1-3-1988; and
vi) pay the costs of the present application and any other claims the Honorable Tribunal may be pleased to decide."

7. The learned counsel for the applicants advanced a number of grounds as under :

a) Railway Board had issued instructions on 3-11-1987 with regard to the method of filling up the vacancies of First Firemen. It was instructed therein that the vacancy in the Grade of First Fireman in the scale of Rs.950-1500 will be filled cent per cent by promotion of second Fireman in the scale of Rs.825-1200 by a process of selection but without any restriction to age or qualification. It is the contention of the applicant that this procedure had not been adopted even though final panels were published only in May, 1988.

b) The number to be empanelled with regard to non-matriculate candidates should have been restricted to one third of the eligible candidates viz. one third of 83. The panel ^{finally} ~~initially~~ announced included 44 names. c) The selections through the two methods were processed simulta-

simultaneously thereby denying the advantage to those matriculates who had failed in the normal mode of selection where all those with 8th class and below 45 years of age were considered, another chance if the Departmental Examination for the matriculates had been conducted separately later, and (d) Seven candidates in the selection pertaining to non-matriculates were added in the supplementary list for extraneous considerations.

8. The learned counsel for the respondents mentioned that the Railway Board Circular dt. 3.11.1987 was circulated by the South Eastern Railway only on 1-3-1988 with suitable elaboration regarding implementation. By that time the selection process in both modes had already been more or less completed. In fact part panels had already been issued in both selections, by the time the headquarters letter was received. Reference was made to [AIR 1983 SC 852] Y.V.Rangaiah and others Vs. J.Sreenivasa Rao and others; and the State of A.P. Vs. J.Sreenivasa Rao and others, wherein it has been held that the posts which fell vacant prior to amended rules would be governed by the old rules and not by the new rules. Since the instructions were received by the Division concerned only in March, 1988, by which time the process of selection by both the modes were more or less completed and that too in regard to the vacancies which had been computed on 15-10-1987 and thus even prior to 3.11.1987 of Railway Board's instructions whereby the amendment was introduced, we cannot hold the said selection conducted as per old rules to be illegal.

9. As regards the contention that empanelment should be restricted to one third eligible candidates with reference to non-matriculate category, no specific instructions could be produced. On the other hand the Railway Board's instructions specify that the '3 X' formula will be observed subject to availability of eligible and willing candidates (Master circular No. 31-E(NG)1/90 PM1/41 dt. 31.7.1991). The earlier circular of Railway Board dt. 3.9.1976 relied upon by the learned counsel for the applicant cannot hence be held as applicable.

10. As regards the contention that simultaneous processing of the two modes of selection should not have taken place, there are no specific instructions prohibiting the same. A matriculate candidate who is included in the eligibility list on the basis of seniority for the selection from amongst non-matriculいたes is not prevented from simultaneously volunteering for selection by the other mode viz. from amongst matriculates and if he gets selected in both, he will naturally prefer inclusion in former which may give advantage in seniority. Thus no prejudice should be caused to any candidate by holding the two modes of selections simultaneously. Hence, this contention does not hold force.

11. In the reply filed by the respondents, it has been stated that the seven candidates whose inclusion has been questioned in the OA appeared at the selection on 19.10.1987 (held for non-matriculいたes) but their names could not be included in the part panel as these seven candidates had not completed two years of service required for empanelment and they were juniors to the candidates who were absent.



However, their names were included in the final panel on 16.5.1988 by which time they had completed the minimum 2 years in the lower grade. Even as per Railway Board's letter No.E(NG)1/85/PM1/13 RRC dt. 12.2.1987, the conditions of two years of minimum service has to be satisfied only at the time of actual promotion and there is no ban on empanelment at an earlier stage. Hence, it follows that even if the employee had not completed 2 years at the time of announcing selection he could still be considered for the selection but promotion as such can be given only on completion of the minimum two years service in the lower grade. Hence, we do not find any irregularity in the inclusion of seven candidates referred.

12. Sri Ram Mohan Rao, learned counsel for the respondents No.33, 43, 45 etc. contended that some respondents had already been promoted to higher grades even by the date this OA has been filed and thus there are latches on the part of the applicants in approaching this Tribunal and if the relief claimed for the applicants is going to be granted it will cause prejudice to the respondents who have already been promoted. AIR 1970 SC 479 Sheikh Abdul Sattar Vs. Union of India was referred to in support. There is no need to advert to this position for disposal of this O.A.

13. In the result, the O.A. is dismissed. No costs.
