Heard Shri P.Krishna Reddy, learned counsel for the applicants and Shri J.R.Gopala Rao, learned standing counsel for R-1 and R-2.

2. This OA was filed praying for direction to the respondents to restore the seniority of the applicants basing on the seniority in the grade of Skilled (Electrical Fitters) under the Shop Superintendent (Electrical) in Wagon Workshop, Guntupalli as per the seniority list for the Skilled (Electrical Fitters) in the workshop, published by the Office Order No.NA/37/88, dated 14.3.88 and for setting aside the seniority list of Electrical Fitters Grade-III of 15.9.1991 published by the Workshop Personnel Officer's order dated 10.12.1991 ~~passed on the representation of the applicants~~ and for setting aside the consequential order of reversion No. GR/P.535/6/1/Vol.VIII/, dated -3-92 served on 30.3.92 and to continue them as Electrical Fitters in HSK Grade-II in the pay scale of Rs.1200-1800.

3. The interim order of status quo was passed on 27.4.92 and it is stated that in view of the said interim order, the applicants are being continued as HSK Grade-II Electrical Fitters in the pay scale of Rs.1200-1800.

4. It is stated for the applicants that their seniority was restored as per the seniority list of Electrical Fitters in the HSK Grade-II as on 1.3.94 and hence this OA had become infructuous.


5. R-3 to R-8 were impleaded as respondents herein as they were shown above the applicants in the seniority list of 1991.

6. Hence this OA is dismissed as infructuous. But this order does not debar R-3 to R-8 if so advised, to resort to such proceedings as are opened to them if they are aggrieved by the seniority list of Electrical Fitters HSK Gr.II as on 1.3.94. No costs.//
