This O.A. was filed by the applicants praying for a direction to the respondents to give proforma promotion with fixation

of pay and arrears and other consequential benefits which are due to the applicants from the day they are due for promotion.

2. Similar O.A. has been filed by similarly situated applicants in O.A.No.807/92 which has been disposed of by this Tribunal on 28.4.1993 with the following directions:

"Para-16: The applicants 1 and 2 joined the Repair Workshop at Tirupathi on 28.9.1987 and the applicants 3 to 6 joined the said Workshop on 24.3.1986, 7.2.1986, 7.2.1986 and 24.3.1986 respectively. Sri A.Nagarajan, junior to the applicant was promoted to Grade-II on 30.8.1984 and later on he was promoted to Grade-I on 28.5.1986. The applicants 1 and 2 had to be given notional promotion in Grade-II and Grade-I on the same date i.e. ^{28.9.1987} ~~28.5.1986~~. The notional promotion in Grade-II in regard to the applicants 3 to 6 had to be given on 24.3.1986, 7.2.1986, 7.2.1986 and 24.3.1986 respectively and all of them had to be given notional promotion in Grade-I on 28.5.1986."

Para-17: In the result, the O.A. is dismissed in regard to the arrears of difference of pay and it is ordered in regard to the notional promotion as referred to above.
No costs. "

3. Accordingly, this O.A. is disposed of on similar lines as under.

4. The applicants 1 to 10, 12, 14 and 15 had joined Carriage Repair Workshop, Tirupathi on 23.11.1987, 28.9.1987, 16.3.87 (applicants 3 to 10, 12, 14 & 15). Sri Abdul Waheb, junior to the applicants was promoted to Highly Skilled Grade-I on 23.12.1986. The above applicants had to be given notional ^{and Grade-I} promotion in Grade-II/with effect from their ^{respective dates of} ~~same date i.e. 4.8.86~~ ^{joining the CRS} 23.12.1986, respectively. The applicants 11 and 13 joined Repair Workshop, Tirupathi on 6.2.1986. Sri B.Abdul Waheb, junior to the said applicants was promoted to Highly

Skilled Grade-II on 4-8-1986 and Highly Skilled Grade-II^I on 23.12.1986. The applicants 11 and 13 had to be given notional promotion in Highly Skilled Grade-II with effect from 4.8.1986 and further to Highly Skilled Grade-I with effect from 23.12.86.

5. The O.A. is dismissed in regard to the arrears of difference of pay and it is ordered in regard to the notional promotion as referred to above. No costs.
