This OA is filed with a prayer to direct the respondents to appoint the applicants as skilled artisans in the scale of Rs.950-1500 (RSRP) in C.R.S.Tirupati pursuant to the panel dated 21-3-1987 published by the Deputy Chief Mechanical Engineer in the Trade of Fitters and Allied Trades and in the meanwhile ~~direct the respondents~~ to appoint the applicants in the posts


of Khalasis in the Artisan Category out of the 40 vacancies notified in Employment Notice 1/91 or in the alternative appoint them as Khalasis in the Diesel Sheds of Guntakal Division in terms of the offer of alternative appointment issued by the Deputy Chief Mechanical Engineer, in his letter No.TR/P.563/DR/VOL.II dated 15-4-1991 and later absorb them as Skilled Artisans as and when the vacancies arise in C.R.S. or elsewhere in South Central Railway, and pass such other order or orders as deemed fit by the Tribunal.


2. MA.111/93 is filed seeking permission to file single OA. Permission is granted and the MA is allowed.

3. The case is covered by the facts and circumstances ^{obtaining} ~~pending~~ in OA.103/92. Heard Sri K. Sudhakar Reddy, Counsel for the applicants and Sri Venkat Malla Reddy, Standing Counsel for the Railways.



Under these circumstances we give the same directions to the respondents in this case also as in OA.103/92 viz., "We direct the respondents that as and when the Group 'D' posts in the outsiders' quota become available at Carriage Repair Shop, Tirupati, or anywhere else in the Guntakal Division, the applicants should be considered first before considering any other case in the order of their rank in the empanelment for Group 'C' posts".

5. With the above direction the application is disposed of at the admission stage itself. No order as to costs.
