Hon'ble Tribunal made the following order:-

This O.A. was disposed of alongwith O.A. No. 1132/93 by  
a common order dated 30.11.94.

By letter dt. 20.2.95. filed by the Applicant's counsel  
in O.A. No. 1166/93 it is submitted that in narrating the  
facts in O.A. No. 1166/93 in para 4 of the judgement, some  
typographical error has crept in. Even in O.A. No. 1166/93  
it was stated that the first 2 Applicants are claiming  
stepping up on the basis of the pay of Shri G. Ranganathan  
(Staff No. 81222) while the 3rd Applicant is claiming stepping  
up on the basis of pay of Shri P. K. Kar (Staff No. 80814). But  
para 4 of the judgement reads that even the 3rd Applicant  
is claiming stepping up on the basis of the pay of  
Shri G. Ranganathan (Staff No. 81222). Hence para 4 of the  
judgment dt. 30.11.94 has to be modified as under:-

Delete para 4 of the judgement dt. 30.11.94 and  
add instead.

" The Applicants numbering 3 in O.A. No. 1166/93  
are working as Accounts Officers under the control of R-1  
Dept of Telecommunications, A.P. Hyderabad. This O.A.  
was filed praying for stepping up of their pay in the  
cadre of Accounts Officer ~~so as to equal of Accounts Officer~~  
so as to equal to the pay of Shri G. Ranganathan (Staff  
No. 81222) in the case of the first 2 Applicants and equal
