senior foremen from one cadre to another cadre ~~will~~ be transferred depending upon the requirement and the total number of sanctioned posts will remain the same. This would mean that though the post is operated in one cadre the same will be shifted to any other cadre due to some reason or other. This would mean that employees in that particular cadre where the post of senior foreman is abolished will lose chance for promotion, ~~that is not the~~ of the chart. The chart indicated the promotional prospects of the employees and once the post of senior foreman is allotted to a cadre the same cannot be operated in any other cadre ignoring the provisions in the chart. It may be possible that due to non-availability of work the post of senior foreman in that cadre may be abolished and a fresh post created elsewhere. Without doing shifting from one cadre to another ignoring the provisions is irregular. Hence we do not find any error in the judgement referred to above.
