(AS PER HON'BLE SHRI JUSTICE V.NEELADRI RAO, VICE CHAIRMAN)


Heard Shri P.Krishna Reddy, learned Counsel for the applicants and Shri N.V.Ramana, learned Standing Counsel for the respondents.


2. A provisional seniority list in the grade of Diesel Assistants as on 30.11.1991 was published in the letter dated 31.1.1992. The said provisional seniority ^{list} is sought to be revised by the proposed seniority list which was published under letter No.CP/371/ELR, dated 15/16.9.1993.

3. This OA was filed on 27.9.1993 praying for a direction to the respondents to maintain the seniority of the applicants in the grade of Diesel Assistants as published in the letter dated 31.1.1992 as on 30.11.1991. It is stated that even the applicants submitted their objections to the proposed seniority list published on 15/16.9.1993. So, it is for the concerned authority to consider the objections of the applicants and also the objections of others, if any, before finalising the seniority. Hence, this OA is premature. Suffice it to observe that if ultimately the applicants are aggrieved on the basis of their final seniority, they are free to move this Tribunal, if so advised.

4. It is stated for the respondents that no one from the category of Diesel Assistants will be sent for promotional training till the seniority list is finalised. Hence, no order need be passed even in regard to the interim relief claimed.

5. In the result, the OA is dismissed as premature. No costs.
