This OA was filed praying for declaration that his request for fixation of pay at Rs.470/- per month with effect from 24.10.1980, the date on which he was promoted as SG and his demand for fixation of his pay at Rs.1800/- with effect from 1.1.1986 in the revised pay scales are fully justified and for respondents to refuse his pay accordingly after granting the annual increment with effect from the original date ie., from 1st October every year and for payment of arrears.

2. Reply was filed for the respondents in this O.A.

3. Shri N.R.Devare, for the respondents submitted that the applicant was Stenographer Grade-I with effect from 1.4.1994, and then the applicant had given his option for pay fixation from the date of his annual increment due on 1.4.1994 and then his ~~pay~~ basic pay was at Rs.2180/- and the entry has been promulgated in the Office Order No.15/94, dated 18.6.1994.
