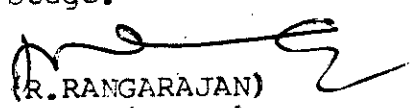

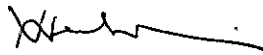
(AS PER HON'BLE SHRI JUSTICE V. NEELADRI RAO, VICE)

for the applicants and V. Bhimanna, learned standing counsels for the

2. All these OAs were disposed of, but they were

learned counsel for the applicants. It is submitted
that when the above OAs were disposed of in pursuance
of the Judgment of the Full Bench in OA 395/90 on
