


The review applicant is the applicant in the OA.

2. The applicant wants the final order passed by us on 13.7.94, reviewed on the ground that the decision taken by us is against the law laid down by the Hon'ble Supreme Court. We do not find any error apparent on the face of the records or on the question of law in the order requiring the order to be reviewed. Even if the applicant or his counsel was present during the hearing of the OA, the situation would not have been different and conclusion reached could only have been the same. Therefore, finding no justifiable ground to entertain the review in the matter, we reject the review application by circulation.
